Crime Figures For June 01/06/2022 to 30/06/2022.

01/06/2022- Road Related Offence

Caller reporting that a vehicle has just crashed into the front of their property on Roundhill Road and the driver/ passengers have made off from the location. Details of the vehicle have been passed to the call handler for the relevant checks to be completed. Vehicle involved believed to be stolen, two arrests have been made in connection to the incident.

02/06/2022- ASB Environmental

Caller reporting that there seems to be a Jubilee party underway along Strait Lane. Caller can hear shouting and abusive language but cannot see what is ongoing. Due to the incident being reported on the Jubilee Weekend Response supervision decides it is not necessary to attend the incident at this time unless further calls are made/ noise continues late into the evening/ morning.

05/06/2022- Suspicious/ Insecure

Caller reporting that there is a vehicle parked opposite their house on Friars Pardon, that has been there for the last 5-6 days. It is partially blocking the footpath. Vehicle checks were conducted and all in order. Not in Police interest.

07/06/2022- Concern/ Collapse/ injury/ Illness

Caller reporting concerns for a female walking along Church Row. Female appears to be intoxicated and is asking for a lift. Officers attended and conducted an area search, no trace for the female.

07/06/2022- RTC

Report from ambulance to say there has been an RTC on Croft Road, involving a motorbike and an artic lorry. Details passed to the call handler for the relevant checks to be conducted. Police arrived on scene to assist ambulance.

07/06/2022- Burglary Business/ Community

Caller reporting that they believe they have had an item of jewellery stolen from their hotel room when staying at Rockliffe Hall. The incident has been crimed and is currently under investigation, the hotel staff have been incredibly helpful during this time.
